| **TERMS** AND CONDITIONS

THESE TERMS OF USE CONTAIN A BINDING ARBITRATION CLAUSE AND CLASS ACTION WAIVER THAT IMPACT YOUR RIGHTS ABOUT HOW TO RESOLVE DISPUTES PLEASE READ IT CAREFULLY.

Introductory Terms:

This agreement is made by and between you and INGOT Coin and has the legal effect as a legal contract. The operator of INGOT Coin means the legal entity that is recognized by law and operates the IC Ecosystem. Please refer to the company and license information at the bottom of the INGOT Coin website for the information regarding INGOT Coin. The operator of INGOT Coin may be referred to, individually or collectively, as “INGOT Coin” in this agreement. “IC Ecosystem” means the all components operated by INGOT Coin, including but not limited to the INGOT Coin website and its affiliate websites, with the domain name of [ingotcoin.io](https://www.ingotcoin.io), <https://www.ingotcoin.io>, which is encrypted. If you do not agree to be bound by these Terms, do not access or use the Services.

INGOT Coin reserves the right to change or modify the terms and conditions contained in these Terms, including but not limited to any policy or guideline of the Site, at any time and at its sole discretion. We will provide notice of these changes by posting the revised Terms to the Site and changing the “Last Revised” date at the top of the Terms, or by emailing Users at their provided email addresses, or by any other means as determined appropriate by INGOT Coin. Finally, you represent and warrant that you will not be using this site for any illegal activity, including but not limited to illegal gambling, money laundering, fraud, blackmail, extortion, ransomware or the financing of terrorism, or other violent activities.

Notwithstanding the foregoing, INGOT Coin may not make the Services, in whole or in part, available in every market, either in its sole discretion or due to legal or regulatory requirements, depending on the User’s location.

Account Opening and Funding Terms

You hereby confirm that you are an individual, legal person or other organization with full capacity for civil rights and civil conducts when you complete the registration or actually use INGOT Coin Services in any way allowed by INGOT Coin. If you do not have the said capacity, you and your guardian shall undertake all the consequences resulted therefrom, and INGOT Coin shall have the right to cancel or permanently freeze your account and claims against you and your guardian for compensation.



In order to access and use the Ecosystem, you must create an account with INGOT Coin (an "Account"). You agree to

- provide accurate, current and complete information when creating the Account;
- maintain and promptly update your Account information to keep it accurate, complete, and current;
- maintain the security and confidentiality of your login credentials and restrict access to your Account and your computer, tablet, or mobile device;
- promptly notify INGOT Coin if you discover or otherwise suspect any security breaches related to the Site or your Account; and
- take responsibility for all activities that occur under your Account and accept all risks of unauthorized access.

You must provide INGOT Coin with a valid email address or mobile number to create an Account. You agree to keep your email address on file with us updated. You must provide your real name, ID type, ID number and other information required by the laws and regulations. You may withdraw your consent to receive emails by sending a withdrawal notice to INGOT Coin, understanding that INGOT Coin may suspend or terminate your ability to use the Services. You understand and agree that if INGOT Coin sends you an electronic communication but you do not receive it because your email address on file is incorrect or out of date, or because our email is blocked by your service provider or intercepted by your spam filter, or you are otherwise unable to receive electronic communications, INGOT Coin will be deemed to have provided the communication to you regardless.

When you elect to transfer currencies (fiat and crypto) from your Account to a third-party wallet or other location, it is always possible the party administering the new location may reject your transfer or that the transfer may fail due to technical or other issues affecting our platform. You agree that you shall not hold INGOT Coin liable for any damages arising from a rejected transfer.

INGOT Coin reserves the right to limit the number of Accounts that any User or such User's affiliates can open or hold.



Security of Account

You shall be solely responsible for the safekeeping of your INGOT Coin account and password on your own, and you shall be responsible for all activities under your log-in email, INGOT Coin account and password (including but not limited to information disclosure, information posting, consent to or submission of various rules and agreements by clicking on the website, online renewal of agreement or online purchase of services, etc.). You hereby agree that

- you will notify INGOT Coin immediately if you are aware of any unauthorized use of your INGOT Coin account and password by any person or any other violations to the security rules;
- you will strictly observe the security, authentication, dealing, charging, withdrawal mechanism or procedures of the website/service; and
- you will log out the website by taking proper steps at the end of every visit.

INGOT Coin shall not and will not be responsible for any loss caused by your failure to comply with this provision. You understand that INGOT Coin needs reasonable time to take actions upon your request, and INGOT Coin will not undertake any responsibility for the consequences (including but not limited to any of your loss) that have occurred prior to such actions.

General Compliance

Legal aspects are key to the success of INGOT's Ecosystem, as we will need to obtain the necessary regulatory approvals in the market(s) where we will operate. In any case, INGOT will always endeavor to comply with any applicable law and regulation. We recognize the importance of complying with the regulations applicable in operating locations, with regards to token sales, cryptocurrencies, and trading derivatives. INGOT will ensure that all required licenses and authorizations are obtained.



The IC Token

The IC is a tool to be used in trading on the INGOT Exchange or to be used in the community. The IC should not be expected to gain value or have value outside of this role. A token is only used by the token owner, and any time it is used. The IC is not an investment in any way and is not a security. The possession or ownership of the coin does not grant any title, right, or interest in any company, enterprise, or undertaking, and does not grant the owner a share of any revenue or profits outside of the capital gains (or losses) they might realize in trading on the INGOT Exchange or community. Passively holding or “Hodling” the IC should have no expectation of profit or value.

INGOT Coin does not have any ability to prevent or mitigate attacks on blockchain networks. With respect to its Ecosystem, INGOT Coin reserves the right to take the following commercially reasonable actions in the event of an attack:

- If INGOT Coin is able to confirm that a Token active on the Ecosystem has been compromised or is under attack, INGOT Coin may immediately halt trading, deposits, and withdrawals for such Token;
- if it is determined that such an attack caused the Token to greatly decrease in value, INGOT Coin may discontinue trade activity on such Token entirely. Poloniex does not have any obligation to engage in activity in relation to attacks on blockchain networks.

Resolutions concerning deposits, withdrawals, and Participants' balances for an attacked Token will be determined on a case-by-case basis by INGOT Coin in its sole discretion. INGOT Coin makes no representation and does not warrant the safety of the Ecosystem and is not liable for any lost value or stolen property, whether or not INGOT Coin was negligent in providing the proper security.



Privacy Policy

Your privacy is important to us. We only share your information with third parties as outlined in our Privacy Policy or as required to do so by law enforcement, court order, or in compliance with identity verification or legal reporting obligations in INGOT Coin sole judgment.

COPYRIGHT INFRINGEMENT
